AMENDMENT TO MASTER DEED
FOR
GARDINER LAKE CONDOMINIUMS
PHASE 4

THIS DECLARATION made and entered into this 15th day of October, 1984,
by GARDINER LAKE CONDOMINIUMS, INC., a Corporation, hereinafter referred to
as "Developer".

W I T N E S S E T H:

WHEREAS, the Developer acquired certain property in Jefferson County,
Kentucky, by Deed dated July 27, 1979, of record in Deed Book 5107, page 801,
in the office of the Clerk of Jefferson County, Kentucky, and now desires to
submit Building 7 of said property to the Horizontal Property Regime known
as GARDINER LAKE CONDOMINIUMS.

NOW, THEREFORE, pursuant to the power retained in Master Deed and
Declaration of Gardiner Lake Condominiums, dated January 15, 1982, of record
in Deed Book 5720, page 741, in the office aforesaid, the Developer does
hereby declare, establish and create Building 7 as Phase 4 of Horizontal
Property Regime pursuant to the Act and does hereby submit Building 4
to said Condominium in accordance with the terms and conditions of the
original Master Deed as set out above and this Amendment affecting the
property as shown on the Plans of Building 7 recorded in Apartment Owner-
ship Book 33, pages 3 through 4, which plans are hereby incorporated
by reference herein and made a part hereof.
