AMENDMENT TO MASTER DEED

FOR

BROOKLEY PLACE

THIS DECLARATION is made and entered into this 1st day of June, 2005, by Brookley Place, LLC, a Kentucky limited liability company, hereinafter referred to as "Developer".

WITNESSETH;

WHEREAS, the Developer acquired certain property in Jefferson County, as referenced in Deed, dated March 9, 2001, of record in Deed Book 7607, Page 170, in the office of the County Clerk of Jefferson County, Kentucky; and

WHEREAS, the Developer submitted a part of the above-referenced property to the condominium form of ownership and use by Master Deed dated December 1, 2003, of record in Deed Book 8312, Page 001, in the office of the Clerk aforesaid; and

WHEREAS, the Developer now desires to submit Phase III consisting of four (4) additional residential units in Building 26 of said property to the Horizontal Property Regime known as Brookley Place and to record an amended plat correcting certain survey and boundary descriptions;


NOW, THEREFORE, pursuant to the power retained in the

aforementioned master deed, the Developer does hereby amend the aforementioned master deed to declare, establish and submit Phase III consisting of the additional residential units shown on the attached Exhibit A to the condominium regime created therein as shown on the original Plans previously recorded in Apartment Ownership Book 99, Pages 36 through 38, in the office of the Clerk aforesaid, and the previous amendments thereto, and as amended by the amended Plans recorded in Apartment Ownership Book 108, Pages 57 through 58, all of which are hereby incorporated by reference herein and made a part hereof.

The percentage of ownership of each unit in Brookley Place is hereby amended as shown on the attached Exhibit A which is incorporated herein by this reference.


